Resolution of Board of Management Meeting of Krishna Institute of Medical Sciences "Deemed To Be University" held on 26th June 2019.

#### BOM-05/21/18-19 To appoint a fulltime Co-ordinator /Director for IQAC

Registrar informed the members that KIMSDU is scheduled to undergo NAAC – 2 cycle reaccreditation after 15<sup>th</sup> November 2020. As mentioned in the Health Sciences Manual for Universities, a full time Director/Co-ordinator for the IQAC has to be appointed. The responsibility and role of IQAC has increased significantly in quality mandates, newer ranking and accreditations initiatives.
