Eligibility Criteria: (For B. P. Th. & B. Sc. Nursing) –

- 1) Candidate must be 17 years on or before 31/12/2021
- 2) Candidate must have passed Std. XII (HSC or equivalent) with Physics, Chemistry, Biology & English individually with minimum 45% marks in PCB, 5 % relaxation of marks for backward class categories.

Eligibility Criteria: (For B. Pharmacy) –

- 1) Candidate must be 17 years on or before 31/12/2021.
- 2) Candidate must have passed Std. XII or equivalent Physics and Chemistry as compulsory subjects along with one of Mathematics or Biotechnology or Biology individually with minimum 45% in PCB / PCM / PCMB, 5 % relaxation of marks for Backward class categories.

Eligibility Criteria: (For B. Sc. Perfusion Technology , B. Sc. Medical Imaging Technology & B.Sc. Cardiac Care) –

- 1) Candidate must be 17 years on or before 31/12/2021
- 2) The candidate must have passed 10+2, or equivalent with Physics, Chemistry, English and Biology with a minimum of 50% marks taken together in Physics, Chemistry and Biology.
