Annexure - I

Modifying and realigning the Strategic Plan of the University in consonance with the National Education Policy

PREAMBLE

Ministry of Education Government of India have come out with National Education Policy 2020 which is indicative of the direction of the Education at all levels to be effected prospectively for fulfilment of the set out objectives.

The said document clearly spells out directional indications for all levels of education including higher education and professional as well as technical education as well. The key features as brought out in the said document in the context of higher and professional education are mainly as under:

- 1. Categorizing the Universities into three distinct categories namely
 - a) Research Based Universities
 - b) Teaching and Research Based Universities
 - c) Degree Conferring Autonomous Institutions
- 2. The nature of the Universities apart from the aforesaid categorization would be multidisciplinary in character. It would be a deviation from exclusive monodisciplinary Universities which are in vogue as of now.
- The emphasis in the nature of the courses to be run by the Universities would be to shape then in an interdisciplinary format with incorporation of 'electives' thereunder.
- 4. The structuring of the courses would be 'Credit based' in the modality of assessment would be in terms of 'Choice Based Credit System'.

- 5. The modality of transfer of credits is to be worked out for which a system of Academic Bank of Credits is to be put into operation entitling the learner to have retention of credits including 'add-on' Credit transfers in terms of accumulated credits including retention thereof wherever necessary.
- 6. This entails the academic courses to have 'multiple exits' and 'collateral entry' in such a form that depending upon the prescribed years of the course multiple level conferment's could be made in the form of 'Certificate', 'Degree', 'Degree with Honors', 'Diploma', 'Post-Graduate Degree' and 'Doctoral Degree'.

The indicative directions as brought out in the National Education Policy-2020 need to be evoked in a phasic manner and hence they need to be appropriately reflected in terms of diligent alignment in the perspective development plan of the University. The said directional shifts would be put into place in the country latest by 2035, whereby the update of the plan has to be worked out keeping that in mind.

The professional courses which are run under the ambit of the University are under the Regulatory control of the respective statutory apical council that have been created under the relevant parliamentary enactments. The stipulations in Governing regulations notified by them for the concerned Academic Programmes are binding in nature and mandatory in character.

In absence of the action plan on the National Education Policy-2020 having not been notified as yet and guidelines pertaining to incorporation thereto with reference to the academic programmes under the authority, jurisdiction and ambit of the Governing Regulatory Apical Councils, the initiatives included in the perspective development programme would be in terms of –

- 1. Initiation of academic courses under multiple disciplines to give the University a multidisciplinary character.
- 2. Incorporation of electives in the ongoing academic programmes specially those which are outside the ambit of the Apical Statutory Regulatory Councils.

- 3. Incorporation of Credit System and Choice Based Credit System, Mode of assessment in the academic programmes outside the ambit of Apical Statutory Regulatory Council.
- 4. Invocation of multiple exit and collateral entry in the academic programmes both ongoing as well as to be launched prospectively by appropriate structuring and commensurate level of certification.
- 5. Initiation of an Academic Credit Bank at the University level to begin with in tune with the indicational principles that have been brought out in the National Education Policy Document-2020 and thereby working out the modalities of Credit Retention and Credit Transfers in terms of prescribed governing policy thereto.

Additional plans as per National Education Plan:

- To start courses in humanities, languages, Sciences, Social Sciences, vocational fields & soft skills.
- To establish department of languages/ literature
- To establish department of statistics
- To establish department of modern arts (Music)
- Online assessment and examinations
