Decentralization and Participative Management: Outcomes

Decentralization:

The decentralization model works on the principle of TEAM WORK, under the guidance of Vice Chancellor and other authorities. All the constituent faculties enjoy the participative management and decentralization framework and a freedom of free will and exerting power with accountability. The University has 6 faculties (Medical, Dental, Physiotherapy, Nursing, Pharmacy and Allied sciences). To delegate the responsibilities and to ensure participation in decision making and its effective implementation, from 2016 onwards different autonomous cells were established. All the Deans of constituent faculties are given full autonomy for the day to day working activities for smooth functioning of their respective colleges. In the same manner, the Head of Departments are fully authorized to check on to the day to day activities of their respective departments.


Participative Management:

The University works through the principle of participative management based on handling of all its major activities like academic, general administration, financial and examinations. In addition to established statutory committee structures, well defined decentralization of administration, is achieved through creation of Autonomous Cells and empowering those with targeted authorities. These committees have representations of respective staff members and students who actively participate in the discussions and propose ideas related to the working of the university which helps in achieving participative management. The university has created various autonomous cells such as attendance cell, research cell, examination cell, students' welfare cell and women empowerment cell. The stakeholders (staff and students) are members of various decisions making bodies of the University. The student participation is achieved through having them as invitee on various bodies and committees e.g. College Council. An additional phase wise committee structure such as pre-clinical, para-clinical and clinical are created in which all the constituent colleges strive hard for improved coordination in curricular and academic activities.

Decentralization Process


- KIMSDU has established IQAC on 02nd July 2014 before the 1st cycle of accreditation by NAAC.
- All the work related to IQAC was done by University Officials and the Deans of constituent faculties.
- After the NAAC assessment in the year 2015 the responsibilities of the 7 criteria was distributed to 7 conveners chosen from different faculties.
- Establishment of Standing Committee of Deans to monitor academic concerns.
- Likewise autonomous cells were also established (i.e. Attendance Cell, Research Cell, IPR Cell, Ph.D. Cell, Students Guidance Clinic Cell, Women's Empowerment Cell, University Examination Cell, Placement Cell, Students Welfare Cell, International Students Cell, Value Education Cell, Website Cell, Education Technology Cell, Placement Cell). This was done with the aim to relieve the pressure of academic responsibilities of the Deans.
- The autonomous cells are having autonomous powers and are responsible directly to the Hon'ble Vice Chancellor. Thus decentralization is achieved.
- Establishment of Joint College Council
- Presentation of Developmental Budget in IQAC.
- The post of Dean (Academics) was created in the year 2016. This was also done with the aim to relieve the pressure of academic responsibilities of the Deans and provide them more time to concentrate on administration.
- The constituent faculties are given academic and administrative autonomy. Autonomy of constituent faculties is assured by making respective college council as the decision making forum in all matters of academic research and student discipline. So also the Deans of the constituent faculties are authorized to,
 - > Take decision related to the academic activities, research activities, publication, curricular and cocurricular activities.
 - > Day to day administrative decisions related to students and employees.
 - > To develop and design curriculum as per the need.
 - > The Institution has given autonomy to constituent faculties to form calendar of events, sports activities, curricular & co-curricular activities.
 - > To formulate policies for smooth functioning of the respective Institute.




