#### **ADMISSON PROCESS:**

Candidates desirous of seeking admission to B. Pharmacy, B. P. Th. & B. Sc. Nursing courses under Krishna Institute of Medical Sciences "Deemed to be University" (KIMSDU) should apply online to KIMSDU. The University shall formulate a merit list on the basis of KAIET- 2019-20 which shall be displayed on the University Website <a href="www.kimskarad.in">www.kimskarad.in</a>. The said merit list will be referred to as KIMSDU Merit List – 2019 herein after. The selection will done on the basis of inter se merit of the candidates who shall report for counseling.

The Competent Authority shall invite Application Forms which are available online on our website: <a href="https://www.kimskarad.in">www.kimskarad.in</a>. The forms should be submitted within the stipulated time (from 09/05/2019 to 15/06/2019) as per the instruction given therein.

# For B. Pharmacy -

- 1. Candidate must be 17 years on or before 31/12/2019
- 2. Candidate must have passed Std XII or equivalent Physics and Chemistry as compulsory subjects along with one of Mathematics or Biotechnology or Biology individually with minimum 45% in PCB / PCM / PCMB
- 3. 5 % relaxation of marks for Backward class categories.

### For B. P. Th. & B. Sc. Nursing -

- 1. Candidate must be 17 years on or before 31/12/2019
- 2. Candidate must have passed Std XII (HSC or equivalent) with Physics, Chemistry, Biology & English individually with minimum 45% marks in PCB.
- 3. 5 % relaxation of marks for Backward class categories.

#### INSTRUCTIONS FOR FILLING UP OF ONLINE APPLICATION FORM

Online Application Form available on our website **www.kimskarad.in** can be submitted within the stipulated time as per the following instructions:

Relevant and complete information and data entry is to be made in the online application format by the candidate to obtain the hard copy of the application form.

#### Note:

- 1. Application forms without any of the above mandatory documents will be rejected.
- 2. Application has to be submitted online and **HARD COPY** of the online application and the documents enlisted is to be send to KIMSDU office along with the DD of Processing Fees.

- 3. Please review all the details before submitting the Application Form.
- 4. All the Details given in the application form will be used for further process.
- 5. Once the Application Form is submitted, no change can be made.

# Note: All uploaded documents should meet the criteria as mentioned below: For uploading photo the following procedure shall be adopted:

- 1. Recent colored Photograph with light background.
- 2. The same photo should be used for all the subsequent processes such as Counseling and admission
- 3. The photograph should have a full face view looking into the camera directly. The main features of the face must not be covered by hair of the head, any cloth or any shadow. Forehead, Eyes, Nose and Chin should be clearly visible.
- 4. The photograph should be in JPGE/JPG image format.
- 5. The Scan image should be less than 80 kb and should be of 30mm x 45 mm dimension.

#### For uploading signature the following procedure shall be adhered to:

- 1. Signature should be made with black pen on white paper by the candidate for uploading.
- 2. Dimensions should be 35 x 80 mm and Maximum file size should be 80 kb.
- 3. The image should be JPG/JPGE format.

# **LIST OF DOCUMENTS:**

The candidate should submit photocopies of the following documents along with the application form:

- 1. 12<sup>th</sup> Mark Sheet
- 2. 10<sup>th</sup> Certificate and Date of Birth Certificate (if 10<sup>th</sup> certificate does not bear the same)
- 3. 12<sup>th</sup> Certificate/Provisional 12<sup>th</sup> Certificate
- 4. Caste Certificate (if applicable)
- 5. Age & Nationality Certificate
- 6. Two recent photographs, taken from same negative, without cap or goggles, taken within last six months. One should be pasted on the application form, duly attested by the Principal/Dean of the College or any Gazetted Officer. The other should be stapled to the application form.

#### **ADMISSION GUIDELINES**

- 1. The admission sessions will be conducted at the office of KIMSDU, Karad as per the schedule.
- 2. Only the candidates shall be allowed into the admission hall. The candidates shall be called in the order of their ranking in the Merit List.

#### 3. IMPERSONATION:

In case of impersonation the candidate will be handed over to police and further action will be dealt as per the Indian Penal Code in this matter and if required the cases will be handed over to Appropriate Law enforcing agencies for further investigation.

- 4. At the time of reporting for the admission, the candidate shall produce the documents (original and two sets of photocopies). If the candidate is admitted to either B.Pharmacy, B.P.Th. or B.Sc. Nursing course, these documents shall be retained by the Deemed University till he/she completes the course. If the candidate fails to produce all or any of the documents his/her claim for a seat shall stand instantaneously forfeited.
- 5. The selected candidate shall be required to pay the entire amount of Tuition fee and such other fees as decided by the University on the day of admission itself through bank draft drawn on a bank favoring "Krishna Institute of Medical Sciences University, payable at KARAD.
- 6. Failure to attend the counseling or to pay the fees at the time of admission or failure to submit all the necessary documents in original may result in automatic forfeiture of the claim of the candidates for the selection.
- 7. If any candidate is not able to attend the counseling due to unavoidable circumstances, he/she may authorize any other responsible individual to represent him/her for the admission session. This representative must carry with him/her the letter of authorization in the given format as well as the original documents, two sets of photocopies and DD of tuition fees. If the candidate or his/her representative fails to report for the admission session on the date and time mentioned in the schedule of admission, his/her claim for admission to the B. Pharmacy, B. P. Th. & B.Sc. Nursing course courses shall stand forfeited.
- 8. In case of dispute in the matter of allotment of course or any other matter pertaining to the provisional selection or cancellation of admission, the decision of the Competent Authority shall be final and binding.
- 9. When all the seats in a given course are filled, admission of students to that course will instantaneously cease and Competent Authority, KIMSDU will not be responsible for non availability of the seats and non allotment to the rest of the candidates.
- 10. Candidates selected for admission shall abide by the Rules of the University.
- 11. Admissions made at the admission sessions are provisional. These will be confirmed after verification of eligibility by the University.

#### 12. CANCELLATION AND REFUND:

Refund of fee in case of cancellation shall be in accordance with the provisions of clause 6.2(2) and (3) of the UGC (Institutional Deemed to be Universities) Regulations 2016.
