- 1. Qualifications and Experience for the faculty positions will be as per norms of the NMC/INC/MNC/PCI/UGC.
- 2. Educational Qualification & Experience for the post of **Director Research** will be as per mentioned below.

Education

The candidates must have Master's Degree (or equivalent in health sciences) in a recognized University/Institute.

Experience

- a) 15 years of teaching and / or research experience of which at least 5 years should be in the rank of Professor or equivalent.
- b) A minimum of 8 years of professional experience in the Management of Research Department of a recognized Health Science University.
- c) Outstanding academic credentials and experience in the field of educational research and training
- d) Must have experience in the area of clinical research, health policies and strategies.
- e) Administrative, organizational and leadership capacities besides wide ranging interest in regard to conduct of research on different aspects of University education from a recognized institution.
- f) Must have experience regarding NAAC Accreditation pertaining to research.
- g) Number of Research Publications should be minimum 10 in the International and National Indexed Journal
- h) Candidate should have individual scopus and other publication IDs
- i) Candidates with good citation index and h-index will be preferred

Professor in Health Sciences Faculty with minimum 5 years experience as Professor having experience in quality assurance in HEIs.
